

Sunman Community Park Rules

The Sunman Community Park was created for the enjoyment of the people of Sunman and paid for by tax dollars from its citizens. We hope that you will utilize it fully, keeping in mind that it is a community park and it falls upon us all to protect it so that unnecessary expenses for maintenance and repair can be avoided and that its natural beauty will be mindfully protected. We hope you will enjoy your time.

Hours of Operation: ours of Operation:

- Dawn - Dusk
- During events, 15 minutes after the end of the event.
- Scheduled events are approved until 12am with authorization.

Usage: Drop-in usage is first-come, first-serve. Facility rentals and reservations will have priority use at all times. All organized groups and organizations MUST schedule usage through the Town Hall.

Trash: All trash must be discarded inside designated trash receptacles. No glass containers are permitted on park property. Fines up to \$2500.00 can and will be enforced for violations. Keeping our park clean is everyone's responsibility.

Decorations: Nails, glue, staples, screws and duct tape are prohibited in decorating the facility. If it will leave a permanent mark on the facility in any way, it is prohibited.

Cleaning: Park facilities must be left in the condition in which they were received. Grounds must be free of trash. Restrooms must be left in an orderly fashion with urinals and commodes flushed.

No Open Flames: Candles (excluding small birthday candles) and other open flames are prohibited in buildings. Open fires and fireworks are prohibited on park grounds except as specifically authorized by the Park Board. The provided grills are for charcoal use only. Personal grills may be used 6 feet outside (not under) the shelter.

Parking: Parking will be in designated areas only. Overnight Parking is prohibited. Parking lot is not to be used for working on or repairing vehicles. Parking is not permitted at the picnic shelters. Violators will be towed at the vehicle owner's expense.

Noise: All music and other noise must be kept to acceptable levels and in accordance with the Town's Noise Ordinance.

Alcohol: The consumption or possession of alcoholic beverages may be used in accordance with the State laws. The Town or Park Board may rescind this privilege from a person or a group of persons for a length of time or permanently if it is found that the state laws or park rules have been violated.

Tobacco: Tobacco products may be used in designated areas only. Any products found outside of the provided ash tray will constitute littering.

Controlled Substances: Illegal use of controlled substances is prohibited while on park premises.

Ball fields: At no time may you add material to the fields without prior expressed permission from the Park Board; staff reserves absolute authority to cancel field reservations due to field conditions. Fences are not to be climbed and balls are not to be intentionally kicked, thrown or hit into a fence. (Note: No for-profit instruction is allowed unless contracted through the Town of Sunman.)

Motorized Vehicles: Motorized vehicles are prohibited unless specifically authorized by Parks Board or Town Employee.

Signs: The addition of signage without prior approval is prohibited.

Child Safety: Young children are to be supervised by responsible adults. Any child feeling threatened is encouraged to promptly notify a parent or local authorities for assistance. Convicted sex offenders are prohibited from entering park premises.

Medical Concerns / Emergencies: Patrons with existing medical concerns are encouraged to consult their personal physician before using park facilities. FOR EMERGENCIES, CALL 911.

Vendors: The Park Board will determine where vendors may be situated during special events and other activities. Vendor events and participants must be approved in advance by the Park Board.

Pets: All pets are to be cleaned up after and remain on a leash at all times. All pets must be vaccinated and tagged according to Town Ordinance. Dangerous pets or animals are prohibited.

Lost & Found: The Sunman Community Park or the Town of Sunman are not responsible for lost or stolen items. Park visitors are encouraged to lock their vehicles. For lost items, please notify the Town Hall.

Bicycles, Skates, and Skateboards: Bicycles, skates and skateboards are not permitted under the shelter areas.

Trespassing: Entering park premises outside of normal operating hours is prohibited.

Park Rules: All park rules and applicable town, county, state and federal laws must be abided by at all times. Violations of these provisions will result in the loss of the ability to use the park at the discretion of the Park Board or Town Council. Security is enforced by the Sunman Police Department or designee and Ripley County Sheriff's Department.

Liability: The Town of Sunman and all subsidiaries will not be responsible for any injury or damage that occurs while utilizing the park grounds.
