REPORTS

UTILITY – Connor Getz (Report attached)

Randy Zins stated they are actively looking for a new Utility Superintendent as of July 05, 2024.

Cheryl Taylor asked the Council if they were investigating the allegations in Perry Cassidy's resignation letter. Carol Eckstein reported no. Randy Zins stated he needed more information.

Cheryl Taylor read the letter aloud at the request of the public - Dear Council Members, I am writing to formally announce my resignation as Utility Superintendent, effective July 5th, 2024. This decision comes in light of a job offer that I have received, which presents an opportunity I cannot decline. While the financial aspect is a factor in this decision, other significant circumstances have contributed to my choice to step down. During my tenure with the Town, I have experienced both highs and lows, with moments of success and challenges. Regrettably, the Town Council's involvement has been a prominent factor in the difficulties I have faced. The level of stress and drama brought on by certain members of the Council is not conducive to effective leadership. Over the past two years, one individual in particular, Mr. Don Foley, has consistently attacked my character, integrity, and ethics. His persistent harassment, both within and outside of official meetings, has been unwarranted. Moreover, his unreasonable demands, such as attempting to interfere with my military obligations, have created an untenable working environment. Mr. Foley's lack of competence in managing employees and addressing the needs of the Town of Sunman and its residents has only exacerbated the challenges I have encountered. The revelation that he offered my position to another Town employee further solidified the realization that my job security was compromised, regardless of my performance. I believe that my departure will not only be beneficial for my well-being but also serve as an opportunity for the Town to address issues within its leadership structure. I am committed to ensuring a smooth transition and will work diligently to complete any pending tasks before my departure date. I would like to express my gratitude for the support and opportunities I have received during my time as Utility Superintendent. I remain dedicated to the principles of honesty, professionalism, and service, and I hope that the Town will continue to thrive in the future. Thank you for your understanding. OLD BUSINESS/UNFINISHED/TABLED

1. 313 Western Avenue  
Carol Eckstein motioned to proceed, 2<sup>nd</sup> Don Foley. John Kellerman will send certified mail to the owner initiating the process of declaring the property a nuisance under the Unsafe Building Ordinance. Cheryl Taylor reported thousands of dollars in unpaid ordinance violations and property upkeep.  
(Previous Meeting of 05/16/2024 - Carol motioned to declare 313 Western Avenue, Sunman, IN, 47041, a nuisance under the Unsafe Building Code, 2<sup>nd</sup> Don Foley.)
2. Easements for Sewer Extension Project  
John Kellerman will continue to reach out even if he has to go to their door. (Previous Meeting of 05/16/2024 - Easements for Sewer Extension Project – Carol Eckstein motioned to begin the condemnation process for the properties that have not responded, 2<sup>nd</sup> Don Foley.)
3. Insurance  
Cheryl Taylor stated that the insurance premiums increased for both, the town and employee portions, 13.5%, and that the deductible went up, depending on the family size, \$7,000 to \$9,000. She has been working with the insurance company who said they can underwrite a policy with the employee directly and the Town would issue an insurance payment to the employee directly. John Kellerman suggested a meeting with the broker.
4. Fire Contract  
John Kellerman reported the process of additional appropriations. Randy Zins motioned to initiate the additional appropriations process, 2<sup>nd</sup> Don Foley.
5. Winner's Circle  
John Kellerman reported that the developer wants to get their bond back. They want to know what they have to do to get that bond released. The answer is fixing the drainage problem. They were advised to get with an engineer to identifies the issues and get it fixed.

NEW BUSINESS

1. Salary Ordinance Amendment  
Don Foley read Salary Ordinance 2024 Amendment 2 aloud. Carol Eckstein motioned to approve, 2<sup>nd</sup> Don Foley.
2. Pond Permit – Upon reading, it was evident that Ripley County Planning approved the pond permit without town input. Cheryl Taylor will report the pond to the engineers in case it impacts the Stormwater Project.
3. SR 101 Weight Limit – Connor Getz reported a locate on the North side of 101 for the purpose of decreasing the speed limit to 35. Cheryl Taylor will look into get the speed limit on the South end of 101 from 45 mph to 35 mph.

ORDINANCE VIOLATIONS – (Report attached)



Cheryl Taylor reported to Zachary Powell that the 313 Western Avenue and 215 Jackson Street were groomed by the Utility Department and charged accordingly.

John Kellerman will get a form letter on letterhead for ordinance violation late fees.

#### COMMENTS FROM THE FLOOR

Scott Corbin

He thanked the town for acting swiftly on the sewer breach that happened and asked if we heard from IDEM? Cheryl Taylor stated that Doug Price reported the overflow and treatment to IDEM. Scott stated that the creek had not been treated. Cheryl Taylor reported that she was on the phone with him while he was there to treat the creek and that Doug also spoke with the neighbor to the East. Cheryl Taylor reported that Connor and herself took turns ensuring that the lift station didn't overflow again. American Pump and Ludwig was contacted.

Carla Hacker asked what the protocol is for emergencies like this? She stated that Cheryl is the Clerk and that the responsibility should fall on the council and they should take turns being on call.

Cheryl Taylor reported that the lift station did not notify us of the circuit break. Randy Zins explained that the lift station will only notify us if the generator has to kick on. Cheryl Taylor asked if there is anything we can install that would tell us that the unit was going to overflow? Randy Zins stated that there were enunciators on them that caused an alarm or light to flash. You would have to plug it into the high limit switch to trigger it. Cheryl Taylor asked permission to look into that type of mechanism. Randy Zins stated that's was fine.

Don Foley stated that he didn't agree with Perry Cassidy's letter of resignation. Cheryl Taylor stated that there was a lot of witnesses to the accusations.



There was a sewer breach in two areas in the 800 block that was reported to IDEM by Doug, Cheryl and I took turns resetting the circuit to prevent any further overflows. Doug came out Monday morning and treated the breached areas, following up on Tuesday with treatment as well. He also spoke to the home owners. American Pumps came out today and retrieved pump 1 which had stopped working, also found issues with the circuit breakers and solenoids.

It has come to my attention via complaint that you have excavated a pond on your property, without proper permits.  
This is a violation of the zone code.

**Section 80.39: Administration  
(B) Improvement Location Permits.**

Within the jurisdiction of the Ripley County Area Plan Commission, no structure, improvement, or use of land may be altered, on platted or unplatted lands, unless the improvement, or use, and its location conform with the Zoning Code of Ripley County, Indiana, and an Improvement Location Permit of such improvement, or use has been obtained from the Executive Director by the owner(s) of the property or his/her agent.

The above mentioned must be addressed within thirty (30) days to avoid legal action. Zoning violation/s penalties are subject to a fine of not more than Two Thousand Five Hundred Dollars (\$2,500.00) for each violation. Each month or period of 30 days (whichever is less) constitutes a separate offense.

Tad,

Made contact with Mr. Hunt and served him the violation . I believe he is going to make contact with you in the morning. Just FYI his father passed away earlier today.

Mr. Hunt was not aware of a permit being needed in Ripley County. He spoke with the contractor who advised him he does ponds all over Ripley County without permits. I asked Mr. Hunt if he was aware I spoke with the contractor and advised him to shut down the job reference no permit and to make contact with Ripley County Zoning/Planning. Mr. Hunt advised that the contractor did say something to him about it but he also stated he called down to Ripley County and explained what he was doing and the dimensions of the pond and a lady told him he should be ok and to continue.

I asked Mr. Hunt if he was aware Ripley County Zoning/Planning came to the jobsite, he stated no but that explains why the job was suppose to take the contractor till Thursday evening or Friday before completed and they were done Wednesday at lunch. I asked Mr. Hunt if he had contacted 811 before digging he stated no, just like the permit he thought the contractor took care of everything.

After looking at the job the overflow drain to the pond is laid towards Trees Mobile Home Park consisting of a 4" plastic draining tile. This area of Trees Mobile Home Park lays extremely wet with mosquito breeding grounds as it is. If anything the property owner would be better off with that particular area draining into the pond. The area is not graded and looks horrible. Mr. Hunt did advise his plans were to install a fence around the pond and backyard along with a fountain in the pond.

Mr. Hunt was extremely flustered and advised while the contractor was loading his equipment he stated to Mr. Hunt he might want to call down to Ripley County and get a permit just incase someone would drown in it. I advised Mr. Hunt the permit was to be obtained before the start of the job and the drowning issue would be more of a insurance issue.

Contractor responsible for the job is Doug Bergman Excavating LLC. I spoke with Mr. Bergman directly when I spoke to them the first time on Tuesday.






Thank you for contacting the Indiana Department of Transportation (INDOT) with your inquiry. The Seymour District Communications Department has received your message concerning overloaded semis driving through the Town of Sunman.

I have sent your inquiry to the Traffic Investigations Department and their Engineer has reported back to me stating INDOT can restrict large vehicles on its roads if they are oversize or overweight. This is particularly critical at specific bridges. However, any legally sized vehicle is able to use the state highway system. I hope this email finds you well. I am still receiving so many calls on oversized hauls through our downtown that are affecting the structures of some of the historic buildings and other homes along SR 101, cracking foundations. We are



very interested in limiting the weight that can travel through.

Also, can we talk to someone about installing speed tables and painted lines? Maybe even dropping the 45 mph speed limit? There is very little room between the buildings and the roadway, a sidewalk's width only, and we have over 10 businesses where you will find heavy pedestrian traffic. And we will have to consider that school will be out soon and traffic will thicken especially around the local ice cream shop on 101.

I realize that you are probably not responsible for all of what I am asking about but I was hoping you would help me navigate these issues. I'm in unfamiliar territory.

What I do know is that our Town, Main Street, homeowners, and stakeholders are all willing to help. We also have a youth group organizing a "Slow Down in our Town" campaign.
